#### Superintendents Report

Mr. Van Wieren explained the E-Rate program, which is a federal initiative designed to make internet access and telecommunications services more affordable for eligible school and libraries across the United States. WDS applied in January and received notification of being awarded. Of the three bids that were received and reviewed carefully, the bid winner is going to Vector Tech. They were the only company that is willing to complete all phases of the project and the only company that is not subscription based. The PSAT/SAT/M-STEP test windows open soon. High School graduation is set for May 22, 2025. We will be holding two more community events on Wednesday, April 30<sup>th</sup>. Coffee with the Superintendent at 10:00 a.m., followed by another session at 6:00 p.m. Both events will take place in the VAC Conference Room. To close out the Superintendent Report, Mr. Van Wieren addressed the Shoreline incident, stating that he never meant to downplay the incident in his communication. Noting that school staff cannot control what students bring from their homes, we as a district are looking at ways to prevent another occurrence from happening again.
