Hackley Community Care Presentation

Representatives from Hackley Community Care shared information and answered questions. The office (currently located in the middle school) is an E3 site, meaning they only handle mental health situations. HCC is currently in 9 school districts in Muskegon County and Michigan is ranked 4th overall in the U.S. for school-based health centers located in schools. HCC has serviced over 13,000 students, many of which would not have been seen by a healthcare professional if this program was not offered. Before receiving services, parents fill out a consent form for their child. It is state law that children 14 and older can request confidentiality when visiting HCC. However, HCC must notify parents if the situation with the student could pose potential danger and/or harm to that student or to another person. Response by parents has been positive overall.
